#### No. IV.1 Agenda:

Harbormaster Report - Updates on projects and happenings on ACND properties, which may include but not be limited to construction, improvements, and conditions at Rockport Harbor, Cove Harbor, Fulton Harbor, the Festival Grounds, Rockport Beach, Little Bay, public restrooms, other ACND properties and projects status of grants and issues with existing leases

Harbor Master Barrett gave a brief outline of power surge issues caused by a failure of power lines located on Seabreeze Drive. AEP resolved the issues but due to the surges Aransas County Navigation District did experience a loss of equipment. The BBQ pits located on Rockport Beach are currently being reconditioned, reported Harbor Master Barrett. He is anticipating the work to be completed by Spring 2025. Harbor Master Barrett noted that during 2024 the tides had been exceptionally high, this trend has reversed. Currently the area is experiencing excessively low tides which have exposed at some locations significant erosion. Harbor Master Barrett is waiting on quotes relating to installation of a retaining wall near the Beach Annex building. Harbor Master Barrett recognized and expressed the districts appreciation for Chairman Dieckow's leadership of the Aransas County Navigation District over his time serving as Commissioner.
